Assignor further authorizes the Commissioner of Patents and Trademarks of the United States, and the appropriate official in any other country or in any state of the United States, to issue any and all additional trademark and service mark registrations or amended registrations that have been or may be granted upon any application or petition for same, to Assignee, its successors and/or assigns.

Assignor hereby grants to Dean Gournis, partner at Kaplan Papadakis & Gournis, P.C. of Chicago, Illinois, the authority and power to insert on this Agreement any further identification which may be necessary or desirable for purposes of recordation in the United States Patent and Trademark Office, the Trademark Office of any foreign country or any State Trademark Office.
