RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of July 19, 2019 (this "Release") is made by Comerica Bank, a Texas banking association (the "Secured Party"), under the Intellectual Property Security Agreement, dated as of January 30, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") made by Accolade, Inc., a Delaware corporation (the "Debtor") to the Secured Party, and recorded in the records of the United States Patent and Trademark Office at Patent Reel 006079, Frame 0870.

Pursuant to the Security Agreement, the Debtor granted to the Secured Party a security interest ("Security Interest") in the Debtor's Intellectual Property Collateral (as defined in the Security Agreement) (including without limitation those trademarks listed on attached Exhibit A hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringement, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof (the "Released Collateral").

The Secured Party now wishes to release and terminate the Security Interest in the Released Collateral.

THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party releases and terminates the Security Interest in the Released Collateral.
