## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of July 22, 2019, is executed by GOLDMAN SACHS BANK USA, in its capacity as Collateral Agent (in such capacity, “Collateral Agent”), in favor of SCENTAIR TECHNOLOGIES, LLC, a Delaware limited liability company (“Grantor”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (as defined below).

Reference is made to that certain Payoff Letter dated as of July 19, 2019, by and among Collateral Agent, Grantor and the other parties thereto (the “Payoff Letter”).

### RECITALS

A. WHEREAS, Grantor has, pursuant to that certain Trademark Security Agreement dated December 30, 2014, recorded in the United States Patent and Trademark Office (the “USPTO”) on December 30, 2014 at Reel 5431, Frame 0698, (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Security Agreement”) granted to Collateral Agent a security interest in and to all of Grantor’s right, title and interest in, to and under the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, Collateral Agent wishes to terminate and release its security interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, subject to the terms and conditions of the Payoff Letter, Collateral Agent hereby terminates, discharges and releases, without recourse, its security interest in and to the Released Collateral and terminates the Security Agreement. Collateral Agent represents and warrants that: (i) it has the full power and authority to execute this Release and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreement. Collateral Agent acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of Grantor. The Collateral Agent authorizes Grantor (or its authorized representatives, including its legal counsel) to record this Release with the USPTO and other applicable registry at the sole expense of Grantor and agrees to provide Grantor with any information and additional authorization necessary (including, but not limited to, the execution, acknowledgment, procurement and delivery of any further documents and other acts as may be reasonably requested by the Grantor) to fully effectuate the release of the security interest in the Released Collateral.
