RELEASE OF SECURITY INTEREST (TRADEMARK)

WHEREAS, **H. BEST, LTD.**, a Delaware corporation (the "*Grantor*"), granted a security interest in the trademarks listed on Schedule I hereto (the "*Trademarks*"), including the goodwill of the business symbolized by such Trademarks, and all proceeds of any and all of the foregoing, including any causes of action which may exist by reason of infringement thereof, in each case arising under the Security Agreement (defined below) (collectively, the "*Trademark Collateral*") to **ISRAEL DISCOUNT BANK OF NEW YORK**, as Administrative Agent (in such capacity, the "*Administrative Agent*") under the Credit Agreement, dated as of July 19, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), by and among the Grantor, Regent-Sutton, LLC, a New York limited liability company, O & M New York LLC, a Delaware limited liability company, Jacques Moret, Inc., a Delaware corporation, High Point Design LLC, a New York limited liability company, SBH Intimates, INC., a New York corporation, DJM International LLC, a New York limited liability company, Spray Moret, LLC, a New York limited liability company, and Moret SK LLC, a Delaware limited liability company (collectively, with the Grantor, the "*Borrowers*"), the Lenders from time to time party thereto and the Administrative Agent, and **ISRAEL DISCOUNT BANK OF NEW YORK** and **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as Co-Collateral Agents (collectively, the "*Secured Party*"), pursuant to that certain Grant of Security Interest (Trademarks), dated as of July 12, 2018, by the Grantor in favor the Secured Party (the "*Security Agreement*"), which Security Agreement was recorded in the United States Patent and Trademark Office on July 23, 2018, Reel/Frame 6388/0487; and

WHEREAS, the Grantor has advised the Secured Party that the Grantor assigned the Trademarks and the other Trademark Collateral to Ideal Time, LLC, a New York limited liability company (the "*Assignee*"); and

WHEREAS, the Grantor has requested that the Secured Party release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party, for itself and the Lenders party to the Credit Agreement, hereby:

1. Consents to the assignment of the Trademarks and the other Trademark Collateral from the Grantor to the Assignee and releases to the Grantor any and all liens on and security interests in, and all right, title and interest of the Secured Party in and to, the Trademark Collateral, without recourse or representation or warranty, express or implied; and
2. Authorizes and requests the United States Patent and Trademark Office to note and record the existence of the release hereby given.



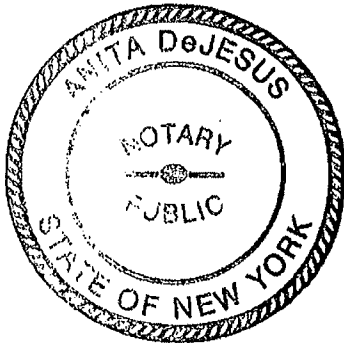
