**INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT**

This INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT is dated as of July 12, 2019 (the “**IP Security Release**”) and executed and delivered by **BANK OF AMERICA, N.A.**, as administrative agent (in such capacity, the “**Administrative Agent**”) for the Secured Parties (as that term is defined in the Credit Agreement dated as of July 9, 2015 (as amended, amended and restated, supplemented or otherwise modified through the date hereof, the “**Credit Agreement**”) among **TENEO GLOBAL LLC**, a Delaware limited liability company (“**Parent**”), **TENEO HOLDINGS LLC**, a Delaware limited liability company (the “**Borrower**”), and **EACH OF THE UNDERSIGNED SUBSIDIARIES OF THE BORROWER** (each a “**Subsidiary Guarantor**” and, together with Parent and the Borrower, collectively, the “**Grantors**”). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Security Agreement (as defined below).

WHEREAS, pursuant to that certain Security Agreement, by and between the parties hereto, dated as of July 9, 2015 (the “**Security Agreement**”), certain Grantors granted to the Administrative Agent a security interest in and to all of such Grantors’ right, title and interest in and to the Trademarks set forth on Schedule A attached hereto (the “**Trademark Collateral**”).

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on July 9, 2015 on reel 005574 frame 0199;

WHEREAS, the Administrative Agent now desires to release its security interest in and to the Grantors’ right, title and interest in and to the Trademarks identified in Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent and the Grantors hereby agree as follows:

SECTION 1. Release of Security Interest. The Administrative Agent does hereby release and convey to the Grantors, without recourse, representation or warranty of any kind, all of the Administrative Agent’s right, title and interest in and to the Grantors’ right, title and interest in and to the Trademarks identified in Schedule A attached hereto.



SECTION 3. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.




