FIRST: The names and jurisdiction of formation or organization and type of entity of each of the constituent entities is: Tourneau, LLC, which was organized as and is a Delaware limited liability company (the "Company") and Baron & Leeds, Inc., which was formed as and is a Hawaii corporation ("Baron & Leeds").

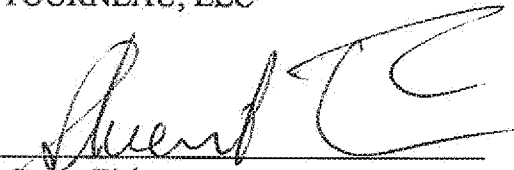
THIRD: The Company shall be the surviving entity of the merger (the "Surviving Company").
