RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of June 17, 2019 (this "Release") is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, as administrative agent on behalf of several banks and other financial institutions (in such capacity, the "Agent") in favor of KLOS-FM RADIO ASSETS, LLC (the "Grantor").

Pursuant to the Guarantee and Collateral Agreement, dated as of June 4, 2018 entered into by the Grantor, each other grantor party thereto, and Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), Grantor, certain affiliates of Grantor, and Agent entered into a certain Grant of Security Interest in United States Trademark Rights, dated as of June 4, 2018 and recorded in the United States Patent and Trademark Office on June 20, 2018, at Reel 6359, Frame 0141 (the "Trademark Security Agreement"), and pursuant to the Security Agreement and Trademark Security Agreement, the Grantor pledged to the Agent for the benefit of the Secured Parties (as defined in the Security Agreement), and granted to the Agent for the benefit of the Secured Parties a continuing security interest in, all of its right, title and interest in, to and under the Trademarks (as defined in the Security Agreement), including the foregoing identified on Schedule A hereto and incorporated herein by reference.

The Agent, on behalf of itself and the Secured Parties, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges the collateral assignment and pledge in and all of its lien on and security interest in, all right, title and interest in, to and under the trademarks identified on Schedule A hereto granted under the Security Agreement and Trademark Security Agreement (the "Released Trademarks"). Any right, title or interest of the Agent in such Released Trademarks shall hereby cease and become void. This Release does not terminate, release or discharge the Agent's security interest in any intellectual property or any other asset of the Grantor or any of its affiliates other than the Released Trademarks, including all other Trademarks (as defined in the Security Agreement).

The Agent hereby authorizes the Grantor or the Grantor's authorized representative to (i) record this Release with the United States Patent and Trademark Office, and/or (ii) otherwise record or file this Release in the applicable governmental office or agency.

This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery by telecopier or by electronic .pdf copy of an executed counterpart of a signature page to this Release shall be effective as delivery of an original executed counterpart of this Release.
