DOES HEREBY CERTIFY:

FIRST: That the name of this corporation is Aethon, Inc. (the "*Corporation*").

SECOND: The Corporation was originally incorporated on June 2, 2004.

THIRD: That the first sentence of Article FIRST of the Certificate of Incorporation, as amended, is hereby deleted in its entirety and replaced by the following:

"FIRST: The name of the corporation is ST Engineering Aethon, Inc."

FOURTH: Pursuant to Section 242(b)(1) of the General Corporation Law, no meeting or vote of the stockholders is required to adopt the proposed amendment.
