TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of July 24, 2019, by Antares Capital LP, in its capacity as administrative agent ("Agent"), in favor of Valicor Environmental Services, LLC, an Ohio limited liability company ("Grantor") pursuant to the Guaranty and Security Agreement (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Guaranty and Security Agreement.

WITNESSETH:

WHEREAS, Grantor and Agent were parties to that certain Guaranty and Security Agreement dated as of June 1, 2017, made by Grantor in favor of Agent (the "Guaranty and Security Agreement");

WHEREAS, Grantor and Agent were parties to that certain Trademark Security Agreement dated as of June 1, 2017 (the "Security Agreement"), pursuant to which Grantor granted a continuing first priority security interest (the "Security Interest") to Agent for the benefit of all Lenders and the L/C Issuers in the Trademark Collateral (as defined below), including the Trademarks set forth on Schedule I hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on June 1, 2017 at Reel 6075, Frame 0255; and

WHEREAS, Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Guaranty and Security Agreement, the receipt and sufficiency of which are hereby acknowledged, Agent hereby states as follows:

1. Agent hereby terminates the Security Agreement and terminates, releases, and discharges its Security Interest, and all of its right, title and interest in and to the following (collectively the "Trademark Collateral") shall hereby cease and become void:

(a) all of its Trademarks providing for the grant by or to the Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule I hereto;

(b) all renewals and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.


2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Trademark Collateral.

3. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
