**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of April 22, 2019 (this “Release”), is made by KeyBank National Association, as administrative agent (in such capacity, the “Agent”), in favor of VanDeMark Chemical Inc., a New York corporation (“VDM”), as follows:

**W I T N E S S E T H**

WHEREAS, VDM, the Agent and the other parties thereto entered into that certain Credit Agreement on September 1, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, in connection with the Credit Agreement, VDM granted the Agent a security interest in certain collateral pledged by VDM pursuant to the Trademark Security Agreement (Trademarks and Trademark Licenses), dated September 1, 2017, which was recorded with the U.S. Patent and Trademark Office on September 7, 2017 at Reel/Frame No. 6148/0151 as further described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the “Trademark Collateral”); and

WHEREAS, VDM has requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.

NOW, THEREFORE, the Agent, without recourse, representation or warranty and at VDM’s sole cost and expense, hereby terminates, cancels and releases any security interest of the Agent in the Trademark Collateral and any all rights, title and interests of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.
