## RELEASE OF TRADEMARK SECURITY AGREEMENT

July 1, 2019

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of September 6, 2017, that was recorded September 14, 2017, at the United States Patent and Trademark Office on Reel: 6155; Frame: 0047 (the "Trademark Security Agreement"), Southwest Stainless, L.P. (n/k/a Sunbelt Supply LP) ("Southwest Stainless") and Floworks International LLC ("Floworks"; and together with Southwest Stainless, collectively, "Grantors"), pledged and granted to Wilmington Trust, National Association, as Collateral Agent (the "Collateral Agent"), to secure the Secured Obligations, a Lien on and security interest in the Trademark Collateral listed on Schedule I attached hereto (the "Released Trademark Collateral"); and

WHEREAS, Grantors have requested and the Collateral Agent has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its continuing security interest in the Released Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Security Agreement referred to therein.

2. Release of Security Interest. The Collateral Agent hereby, without any representation and warranty and without any recourse (a) terminates the Liens and security interests created under the Trademark Security Agreement in the Released Trademark Collateral, (b) releases its security interest in the Released Trademark Collateral, and (c) discharges any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Released Trademark Collateral.

Wilmington Trust, National Association, is executing and delivering this Release of Trademark Security Agreement solely in its capacity as Collateral Agent under the Term Loan Agreement and not in its individual or corporate capacity. In acting hereunder, the Collateral Agent shall be entitled to all of the rights, privileges and immunities under the Term Loan Agreement and the other Loan Documents, as though fully set forth herein.

The Collateral Agent hereby authorizes Grantors and their agents, representatives and designees to record this Release of Trademark Security Agreement with the United States Patent and Trademark Office.


