**RELEASE OF NOTICE OF GRANT OF SECURITY
INTEREST IN PATENTS AND TRADEMARKS
(Junior Subordinated Loan)**

This Release of Notice of Grant of Security Interest in Patents and Trademarks (the "Release") is made and effective as of July 25, 2019 and granted by Harbert Mezzanine Partners II SBIC, L.P., a Delaware limited partnership, as collateral agent (the "Agent"), and in favor of Micro Precision, LLC, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement (Junior Subordinated Loan) dated as of September 16, 2011, by and between Grantor and Lender, Grantor entered into that certain Memorandum of Security Agreement (Patents) (Junior Subordinated Loan) dated September 16, 2011 (the "Patent Memorandum"), which was recorded with the United States Patent and Trademark Office on October 4, 2011 at Reel/Frame 027015/0615 and that certain Memorandum of Security Agreement (Trademarks) (Junior Subordinated Loan) dated September 16, 2011 (the "Trademark Memorandum" and together with the Patent Memorandum, the "IP Security Agreements") which was recorded with the United States Patent and Trademark Office on October 4, 2011 at Reel/Frame 4635/0379;

WHEREAS, the Grantor collaterally assigned to the Agent a security interest in all of the Grantor's right, title and interest in, to and under the patents and trademarks identified in Schedule A attached hereto (the "Intellectual Property"); and

WHEREAS, the Agent has agreed to release its security interest in the Intellectual Property and terminate such IP Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby states as follows:

1. Release of IP Security Interest. The Agent hereby terminates the IP Security Agreements and terminates, releases and discharges any and all security interests that it has pursuant to the IP Security Agreements in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in or to the Intellectual Property.

2. Further Assurances. The Agent agrees, at the Grantor's expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to effectuate or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Tennessee, without giving effect to any choice or conflict of law provision or rule (whether of the State of Tennessee or any other jurisdiction).


