This trademark assignment shall be for the benefit of Assignee, its successors, assigns, and licensees.

2. Assignor agrees to execute such further papers and do such other acts as may be necessary and proper to vest full title in and to the Trademarks in the Assignee or which may be necessary to obtain, renew, issue or enforce the Trademarks.
