ASSIGNOR hereby authorizes and requests the Commissioner for Trademark of the United States and any official of any state or foreign country whose duty it is to issue intellectual property registrations to issue all registrations from any applications for registration of the Trademarks to the Assignee.

ASSIGNOR hereby authorizes Assignee to take all necessary and/or appropriate steps to effectuate this Agreement and the transfer of rights hereunder, including recordation thereof in the appropriate Trademark Offices. Assignor hereby covenants and agrees that, at any time and from time to time after the Effective Date, at Assignee's request, or at the request of Assignee's successors, representatives or assigns, Assignor shall reasonably cooperate with Assignee to execute and deliver such documents and other papers, and otherwise provide reasonable assistance to Assignee, as may be required to grant, transfer, convey, deliver and assign to Assignee any of the Trademarks.
