# STATE OF DELAWARE CERTIFICATE OF AMENDMENT OF CERTIFICATE OF INCORPORATION

The corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

**FIRST:** That at a meeting of the Board of Directors of ParkJockey Global, Inc. resolutions were duly adopted setting forth a proposed amendment of the Amended and Restated Certificate of Incorporation of said corporation, declaring said amendment to be advisable and calling a meeting of the stockholders of said corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

**RESOLVED**, that the Amended and Restated Certificate of Incorporation of this corporation be amended by changing the Section thereof numbered "1" so that, as amended, said Section shall be and read as follows:

1. The name of this corporation is REEF Global Inc. and that this corporation was originally incorporated pursuant to the General Corporation Law on January 12, 2015 under the name ParkJockey Global, Inc. The corporation's certificate of incorporation was restated by that certain Restated Certificate of Incorporation dated as of August 9, 2017, as further amended by that certain certificate of amendment dated March 7, 2018, as further amended by that certain Amended and Restated Certificate of Incorporation, dated as of November 28, 2018 (as so amended, the "*Restated Certificate of Incorporation*").

**RESOLVED**, that the Amended and Restated Certificate of Incorporation of this corporation be amended by changing the Article of Exhibit A numbered "I" so that, as amended, said Article shall be and read as follows:

The name of this corporation is REEF Global Inc. (the "*Corporation*").

**SECOND:** That thereafter, pursuant to resolution of its Board of Directors, a special meeting of the stockholders of said corporation was duly called and held upon notice in accordance with Section 222 of the General Corporation Law of the State of Delaware at which meeting the necessary number of shares as required by statute were voted in favor of the amendment.

**THIRD:** That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
