**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of July 18, 2019 by SUNTRUST BANK, as lender (the "Lender"), in favor of FLORIDA VEG INVESTMENTS LLC, a Florida limited liability company (the "Grantor"). Reference is hereby made to that certain Notice of Grant of Security Interest in Trademarks between the Grantor and the Lender dated as of September 13, 2018 and recorded with the United States Patent and Trademark Office ("USPTO") on September 18, 2018 at Reel 6440/Frame 0460 (the "Trademark Security Agreement"). NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender hereby releases and terminates all security interests it may have in the Trademark Collateral, without recourse, representation or warranty. The Grantor (or its designee) is hereby authorized to file this Release with the USPTO and any other governmental authority.


