RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) is made as of July 26, 2019 by Wells Fargo Bank, National Association, in its capacity as administrative agent (in such capacity, the “Agent”) for the Lenders (as defined in the Credit Agreement referred to in the Trademark Security Agreement (as defined below)), in favor of the Grantor (as defined below).

W I T N E S S E T H:

WHEREAS Manchester Industries Inc. of Virginia, a Virginia corporation (the “Grantor”), executed that certain Trademark Security Agreement, dated as of December 16, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) in favor of the Agent, pursuant to which the Grantor granted a security interest to the Agent in certain trademarks and other intellectual property of the Grantor;

WHEREAS the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel: 5938; Frame: 0883 on December 16, 2016; and

WHEREAS, the Agent has agreed to terminate and release the entirety of its security interest in all collateral secured by the Trademark Security Agreement, including all its liens on the trademarks and trademark applications of the Grantor identified on Annex 1 attached hereto and made a part hereof (the “Released Collateral”), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of the Agent’s right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
