## TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is entered into as of July 26, 2019 by and between Nicole A. Willis (with the married name of Nicole A. Assignor hereby transfers, conveys, assigns and delivers to Assignee all of Assignor's right, title and interest in and to the Trademark, together with the goodwill of the business associated therewith throughout the world and all common law and statutory right, title and interest in and to the Trademark, all rights of registration, maintenance, renewal and protection thereof, and all rights of recovery and of legal action for past infringements and of opposition, interference and/or cancellation proceedings for protection of the Trademark, and all products, proceeds and revenues arising from or relating to any and all of the foregoing. Assignor hereby authorizes Assignee, its successors and assigns to the fullest extent permitted by applicable law, to file in its own name applications for trademark and service mark registration in connection with the Trademark, and to secure in its own name the registrations granted thereon throughout the world. Assignor agrees to provide all assistance reasonably requested by Assignee in the establishment, recordation and enforcement of Assignee's rights in and to the Trademark and authorizes any official of any country empowered to issue trademarks, to record this Assignment, and to issue or transfer the Trademark to Assignee as owner of all right, title and interest herein.

2. This Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original and each counterpart may be delivered by PDF or email transmission, but all of which together shall constitute one and the same instrument.
