## ASSIGNMENT

**Parties** Berkshire Hathaway Specialty Insurance Company, whose principal place of business is situated at 1314 Douglas Street, Suite 1400, Omaha, NE 681021944, United States of America ("Assignor")

and

Columbia Insurance Company, whose principal place of business is situated at 1314 Douglas Street, Suite 1400, Omaha, NE 68102-1944, United States of America ("Assignee").

Together the Assignor and the Assignee may be referred to collectively as the "parties", or each singularly as a "party".

### Introduction:

- (A) The Assignor is the applicant / owner of the trade marks in certain countries as set out in the schedule attached to this agreement ("Trade Marks").
- (B) The Assignor has agreed to assign the Trade Marks to the Assignee, and the Assignee has agreed to accept such assignment, in accordance with the terms of this agreement and its schedule ("Agreement").

### Terms Agreed:

#### 1. ASSIGNMENT

- 1.1 For good and valuable consideration of the sum of ten United States Dollars (US \$10), the receipt and sufficiency of which is hereby acknowledged by the Assignor, the Assignor hereby assigns to the Assignee all of its right, title and interest in and to the Trade Marks and any common law rights and all the goodwill arising from or attached to the business relating to the Trade Marks.
- 1.2 Said Trade Marks to be held and enjoyed by Assignee, for its own use and enjoyment, and for the use and enjoyment of its successors and assigns forever, at common law and/or to the end of the term or terms for which registration of the said Trade Marks may be granted, or renewed, as fully and entirely as the same would have been held and enjoyed by Assignor had the assignment set forth herein not been made; together with all causes of action and the proceeds thereof in favor of Assignor heretofore accrued or hereafter accruing by reason of past infringement, dilution, misappropriation or other

violation of the Trade Marks, with the right to sue and collect damages for its own use and benefit, and for the use and on behalf of its successors or assigns.

1.3 From and after the date hereof, Assignor shall, upon request of Assignee, do, execute, acknowledge, deliver and file, or shall cause to be done, executed, acknowledged, delivered and filed, all such further acts, deeds, transfers, conveyances, assignments or assurances as may be reasonably requested by Assignee to transfer, convey and assign to Assignee possession and use of the Trade marks to comply with all applicable legal requirements to effect such transfers, conveyances and assignments.

1.4 This Agreement may be executed in counterparts and each of such counterparts shall together constitute one and the same instrument and a binding agreement between the parties.




