2. The text of each amendment as adopted is as follows:

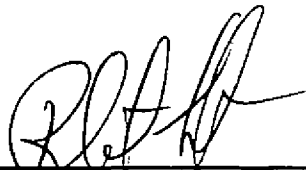
ARTICLE I of the Articles is deleted and replaced with the following:
