## RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made and effective as of April 29, 2019 and granted by PNC Bank, National Association in its capacity as agent for the lenders ("Agent"), in favor of Milk Industry Management Corporation, Balford Farms, Inc., Balford HTD, LLC and Balford Investments LLC (collectively, "Grantor").

WHEREAS, Grantor executed and delivered to Agent that certain Trademark Security Agreement by and between Grantor and Agent dated as of December 30, 2014 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantor pledged and granted to Agent a security interest in and to all of the right, title and interest of Grantor in, to and under the Trademark Collateral (as defined below);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5456, Frame 0879 on February 10, 2015; and

WHEREAS, Grantor has requested that Agent enter into this Release to effectuate, evidence and record the release by Agent of the security interest in the Trademark Collateral pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, intending to be legally bound hereby, Agent hereby agrees as follows:


1. Release of Security Interest. Agent, on behalf of itself and its successors, legal representatives and assigns, hereby terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreement in any of the following (collectively, the "Trademark Collateral"): Grantor's trademarks, service marks and tradenames listed on Schedule "I" attached hereto and made part hereof (collectively, the "Trademarks"), together with all the goodwill of Grantor associated with and represented by the Trademarks, and the registration thereof and the right (but not the obligation) to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits.

2. Further Assurances. Agent agrees, at the Grantor's expense, to take all further actions as reasonably requested, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the Commonwealth of Pennsylvania without giving effect to any choice or conflict of law provision or rule.
