
NOW THEREFORE, for good and valuable consideration paid by Assignee, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:


- 1. "Marks" means any and all of Assignor's right, title, and interest in and to the trademark and service mark registrations and applications as listed on Schedule 1.
