IN WITNESS WHEREOF, said Reliance Trust Company of Delaware, has caused this certificate to be signed by its President, this 16th day of April, 2019.

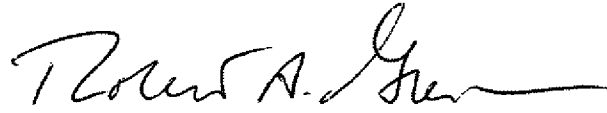
