RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated July 31, 2019 by BANK OF MONTREAL (“*BMO*”), with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, acting as administrative agent hereunder for the Lenders and the L/C Issuers as referred to in the Trademark Security Agreement referred to below (BMO acting as such administrative agent being hereinafter referred to as “*Agent*”);

WITNESSETH:

WHEREAS, STONEWALL KITCHEN, LLC, a Maine limited liability company (“*Grantor*”), with its mailing address at 2 Stonewall Lane, York, Maine 03909 and Agent were parties to a certain Trademark Security Agreement dated December 10, 2018 between Grantor and Agent which was recorded in the United States Patent and Trademark Office on December 10, 2018 at Reel 6497, Frame 0956 (the “*Agreement*”), pursuant to which Grantor granted to Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule 1 attached hereto and certain other property (collectively, the “*Trademark Property*”); and

WHEREAS, Grantor has requested that Agent release its security interests in the Trademark Property and reassign the same to Grantor;

WHEREAS, the Agent desires to terminate and grant a release of its security interest in the Trademark Property as provided in this release;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Agent hereby (a) terminates the Agreement and (b) releases its security interests in, and hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule 1 hereto, including:

- (i) all of its trademarks, including, without limitation, those referred to on Schedule 1 hereto, but excluding any “intent to use” trademark applications for which a statement of use has not been filed (but only until such statement has been filed);
- (ii) all renewals and extensions of the foregoing;
- (iii) all goodwill of the business connected with the use of, and symbolized by, each such trademark; and
- (iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.


