TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of July 31, 2019, is made by Coughlan Companies, LLC, a Minnesota limited liability company (the "Grantor"), in favor of CIBC BANK USA, an Illinois state banking corporation, as collateral agent (in such capacity, "Collateral Agent"), and as administrative agent and a lender (in such capacity, together with its successors and permitted assigns, the "Agent") for the benefit of itself and for the benefit of the Lenders and Senior Noteholder (as defined in the Credit Agreement referred to below) (the Lenders and Senior Noteholders shall hereinafter be referred to as the "Secured Parties").

WITNESSETH:

The Lenders have severally agreed to extend credit to Grantor and others, pursuant to the Credit Agreement of even date herewith by and among Agent, the Lenders and the Grantor. The Grantor and the Senior Noteholders are party to the Note Agreement pursuant to which the Senior Noteholders have agreed to purchase the notes issued by the Grantor.

The Grantor has, pursuant to a Collateral Agreement of even date herewith executed by, among other parties, the Grantor in favor of the Collateral Agent (the "Collateral Agreement"), granted the Collateral Agent a security interest in the Grantor's assets to secure the Secured Obligations (as defined in the Collateral Agreement) including, among other things, all of the Grantor's Trademarks;

Pursuant to the Collateral Agreement, the Grantor is required to execute and deliver this Trademark Security Agreement; and

Terms used herein with their initial letter capitalized that are not otherwise defined herein shall have the meaning given to such terms in the Collateral Agreement.

NOW, THEREFORE, in consideration of the premises and to induce the Lenders and the Agent to enter into the Credit Agreement and to induce the Lenders to make their respective extensions of credit to the Grantor thereunder, and to induce the Senior Noteholders to enter into the Note Agreement and to purchase the notes pursuant to the Note Agreement, the Grantor hereby agrees with the Agent as follows:

1. Grant of Security Interest in Trademark Collateral. The Grantor, as collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Secured Obligations of the Grantor, hereby mortgages, pledges and hypothecates to the Collateral Agent for the benefit of the Secured Parties, and grants to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of the Grantor (the "Trademark Collateral"):
 - (a) all of its Trademarks and all related Trademark Licenses providing for the grant by the Grantor of any right under any Trademark, including, without limitation, those trademark registrations or applications for registration referred to on Schedule I hereto;
 - (b) all renewals of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(d) all income, royalties and proceeds at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof,

provided, that in no event shall the definition of "Trademark Collateral" include, nor shall the security interest granted hereunder extend to, any Excluded Collateral.

2. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Collateral Agreement and the Grantor hereby acknowledges and agrees that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
3. Grantor Remains Liable. The Grantor hereby agrees that, anything herein to the contrary notwithstanding, the Grantor shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with its Trademarks and related Trademark Licenses subject to a security interest hereunder.
4. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.
5. Governing Law. This Trademark Security Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the state of Minnesota.

IN WITNESS WHEREOF, the Grantor has caused this Trademark Security Agreement to be executed and delivered by its duly authorized officer as of the date first set forth above.




