RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “*Release*”) is made on this 31st day of July, 2019 by JPMorgan Chase Bank, N.A., a banking association chartered under the laws of the United States (together with its successors and assigns, the “*Lender*”).

WHEREAS, reference is made to that certain Intellectual Property Security Agreement, dated January 17, 2019 (the “*Intellectual Property Security Agreement*”), by GIGAMEDIA ACCESS CORPORATION, a Delaware corporation (the “*Grantor*”), in favor of Lender, which was recorded with the United States Patent and Trademark Office (the “*USPTO*”) on January 17, 2019 in the trademark assignment records under reel/frame number 6528/0822; all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the Intellectual Property Security Agreement or the Credit Agreement, dated as of January 17, 2019, by and between the Lender and the Grantor (as may be amended from time to time, the “*Credit Agreement*”), referred to therein; and

WHEREAS pursuant to the Intellectual Property Security Agreement and the Credit Agreement, Grantor granted Lender a security interest in all of the right, title and interest of Grantor in and to its intellectual property (the “*Intellectual Property Collateral*”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby irrevocably and forever releases and terminates its security interest in and to the Intellectual Property Collateral arising under the Intellectual Property Security Agreement, including, without limitation, the Intellectual Property Collateral

described in Schedule A attached hereto. Further, Lender understands and agrees that this Release may be recorded by or for Grantor with the USPTO and any other similar office or agency throughout the world, and hereby authorizes Grantor to make such filings on Lender's behalf. Lender also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Grantor may reasonable require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.


