## RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (“Release”) dated as of July 24, 2019, is made by COMERICA BANK (“Secured Party”), and is as follows:

WHEREAS, SLEEPMED INCORPORATED, a Delaware corporation (“Debtor”) with its principal place of business located at 1641 Worthington Road, Suite 430, West Palm Beach, FL 33409, and Secured Party are parties to: i) that certain Intellectual Property Security Agreement, dated as of March 27, 2013, which was recorded with the United States Patent and Trademark Office on March 28, 2013, in its records at Reel 4993, Frame 0835 (the “2013 Agreement”); and, ii) that certain Amended and Restated Intellectual Property Security Agreement, dated as of May 21, 2015, which was recorded with the United States Patent and Trademark Office first on May 27, 2015, in its records at Reel 005524, Frame 0349 and again on May 18, 2016 in its records at Reel 5795, Frame 0811 (the “2015 Agreement”); capitalized terms used but not defined herein will have the meaning given to them in the 2013 Agreement and in the 2015 Agreement;

WHEREAS, the Agreement granted to Secured Party a security interest in all of Debtor’s right, title and interest in, to its Intellectual Property Collateral, including, without limitation, i) all of Debtor’s right, title and interest in and to all of its now or in the future owned or existing Trademarks listed on Exhibit C of the 2013 Agreement (attached hereto and made a part hereof as Schedule I); and, ii) all of Debtor’s right, title and interest in and to all of its now or in the future owned or existing Trademarks listed on Exhibit C of the 2015 Agreement (attached hereto and made a part hereof as Schedule II); and, all proceeds thereof, the right to sue for past, present and future infringements, all rights corresponding thereto through the world and all re-issues, divisions, continuations, renewals extensions and continuations-in-part thereof (collectively, the “IP Collateral”); and


WHEREAS, Secured Party desires to release its rights and security interests in the IP Collateral solely as granted under the Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the IP Collateral and (ii) any and all other rights it may have under the Agreement.
