**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of August 1, 2019, by **JEFFERIES FINANCE LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns in such capacity, “Administrative Agent”) in favor of **LOPAREX LLC**, a Delaware limited liability company with an address at 1255 Crescent Green, Suite 400, Cary, North Carolina 27518 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain Trademark Security Agreement dated April 11, 2018 (the “Trademark Security Agreement”) with Administrative Agent, which was recorded on April 11, 2018 at the United States Patent and Trademark Office at Reel 6358, Frame 0297.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted Administrative Agent, under the terms of the Trademark Security Agreement, a security interest in favor of Administrative Agent, in, to and under all of its Trademark Collateral, including without limitation the Trademarks listed in Schedule A.

WHEREAS, Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, for itself and on behalf of the Secured Parties, hereby terminates the Trademark Security Agreement and releases, terminates and discharges any and all of its security interest in and lien upon the Trademark Collateral (including without limitation the trademark registrations listed in Schedule A), including all of the goodwill connected with the use of, and symbolized thereby, and assigns, transfers and conveys to Grantor any and all right, title or interest in, or to, the Trademark Collateral that the Administrative Agent may hold.
