TRADEMARK SECURITY INTEREST ASSIGNMENT AGREEMENT

THIS TRADEMARK SECURITY INTEREST ASSIGNMENT AGREEMENT (this "Agreement") is made and entered into as of this 31<sup>st</sup> day of July, 2019, by CITIBANK, N.A. ("Citibank"), as the prior agent under the Existing Credit Agreement (as defined below) (in such capacity, "Assignor"), in favor of BANK OF AMERICA, N.A., as the successor agent under the New Credit Agreement (as defined below) (in such capacity, "Assignee").

WITNESSETH

WHEREAS, Assignor is party to the Credit Agreement, dated as of June 30, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Existing Credit Agreement"), by and among Herc Rentals Inc., a Delaware corporation ("Herc Rentals"), certain affiliates of Herc Rentals, the lenders from time to time party thereto, and Assignor;

WHEREAS, pursuant to the Trademark Security Agreement, dated as of June 30, 2016 (the "TSA"), made by Herc Rentals and Cinelease, Inc., a Nevada corporation ("Cinelease") and, together with Herc Rentals, each individually, a "Grantor" and collectively, the "Grantors") in favor of the Assignor, which was recorded with the United States Patent and Trademark Office on July 8, 2016 at reel/frame 005831/0250 with respect to Herc Rental's Trademarks and at reel/frame 005831/0222 with respect to Cinelease's Trademarks, each Grantor has granted to Assignor a security interest in, and lien on, all of its right, title and interest in and to the Trademarks (as defined in the TSA) including, without limitation, the trademarks and trademark applications described on Schedule I annexed hereto and made a part hereof that are recorded with the United States Patent and Trademark Office;

WHEREAS, effective as of the date hereof, Assignor resigned as agent under the Existing Credit Agreement and the other Loan Documents (as defined in the Existing Credit Agreement), including, without limitation, the TSA;

WHEREAS, (a) pursuant to that certain Resignation and Appointment of Successor Agent Agreement, dated as of the date hereof (the "Resignation Agreement"), among Assignor, Assignee, the Grantors, certain affiliates of the Grantors party thereto and the Lenders party thereto, Assignee has assumed and succeeded to all of the rights, powers, discretions, privileges and duties of Citibank as agent under the Existing Credit Agreement and the other Loan Documents (as defined in the Existing Credit Agreement), including, without limitation, under the TSA; and (b) the Existing Credit Agreement has been amended and restated pursuant to the Credit Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "New Credit Agreement"), among Assignee, the Grantors, certain affiliates of the Grantors party thereto and the Lenders party thereto; and

WHEREAS, Assignor and Assignee desire to enter into this Agreement to evidence the assignment by Assignor to Assignee of all of Assignor's right, title and interest under the TSA, including, without limitation, Assignor's security interest in, and lien on, the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein shall have the meanings specified in the Existing Credit Agreement.

2. Assignment. Assignor does hereby transfer, assign, grant and convey to Assignee without any representation, warranty or recourse of any kind or nature, except as specifically set forth in the Resignation Agreement, all of its right, title and interest with respect to the Trademarks under the TSA and the other Loan Documents (as defined in the Existing Credit Agreement), including, without limitation, its security interest in, and lien on, the Trademarks, and Assignee does hereby accept and assume all of such right, title, interest, security interests and liens.

3. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York.

4. Counterparts. This Agreement may be executed in counterparts, each of which shall constitute an original and all of which taken together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Agreement by facsimile transmission or electronic mail shall be as effective as delivery of a manually executed counterpart of this Agreement.
