RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT dated as of July 31, 2019 (this “Release”) is made by BREAKWATER CREDIT OPPORTUNITIES FUND, L.P., a Delaware limited partnership, as collateral agent (in such capacity, the “Collateral Agent”) under that certain Trademark Security Agreement, dated as of October 5, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Trademark Security Agreement”) made by BEAR DOWN BRANDS, LLC, a Delaware limited liability company (the “Grantor”) and the Collateral Agent. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Loan and Security Agreement, as applicable.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on October 5, 2017 at Reel 6174, Frame 0711, the Grantor granted to the Collateral Agent, for the benefit of the Lenders, a Lien on and security interest in all of such Grantor’s right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached Schedule A (the “Trademark Collateral”);

WHEREAS, the Grantor has requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest on the Trademark Collateral (the “Released Collateral”).


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Released Collateral.
