


 - e. The Assignor has the authority to enter into this Agreement.

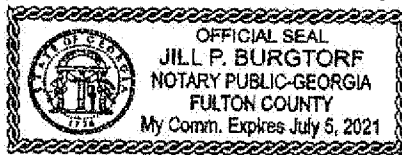
