**SECOND AMENDED AND RESTATED  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS SECOND AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Agreement") is entered into as of June 28, 2019 by and between OCEAN II PLO LLC, in its capacity as collateral agent and as administrative agent for all Lenders ("Agent") and IMVU, INC., a Delaware corporation ("Borrower").

RECITALS

Borrower and Prior Agent previously entered into that certain Loan and Security Agreement dated as of July 20, 2016.

Borrower, certain Lenders party thereto and Prior Agent subsequently entered into that certain Amended and Restated Loan and Security Agreement dated as of December 13, 2017.

Borrower, certain Lenders party thereto and Prior Agent subsequently entered into that certain Second Amended and Restated Loan and Security Agreement dated as of March 28, 2018.

Lender has agreed to make certain advances of money and to extend certain financial accommodations to Borrower under that certain Third Amended and Restated Loan and Security Agreement by and between Agent, Lender and Borrower dated of even date herewith (as amended from time to time, the "Third A&R Loan Agreement"). Capitalized terms used herein are used as defined in the Third A&R Loan Agreement. Pursuant to the terms of the Third A&R Loan Agreement, Borrower has granted a continuing Lien and security interest to Agent in Borrower's personal property.

NOW, THEREFORE, Borrower agrees as follows:

AGREEMENT

To secure the Obligations under the Third A&R Loan Agreement, Borrower grants to Agent a continuing, first priority security interest in all of Borrower's right, title and interest in, its Intellectual Property (including, without limitation, those Copyrights, Patents and Trademarks listed on Schedules A, B and C hereto) whether now existing or hereafter arising, and all proceeds thereof (such as, by way of example, but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof, subject to the terms of the Third A&R Loan Agreement. Borrower represents and warrants as of the date hereof that Schedules A, B and C attached hereto set forth all intellectual property rights in connection to which Borrower has registered or filed an application with either the United States Patent and Trademark Office or the United States Copyright Office, as applicable. Borrower agrees to update the Schedules hereto in writing and send the same to Agent not less than quarterly as provided in the Third A&R Loan Agreement with respect to any updates, modifications or additions to the intellectual property rights of Borrower. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument. Borrower acknowledges and agrees that this is a continuing Lien and security interest, originally granted to the Prior Agent and that such Lien and security interest was originally perfected on or about July 20, 2016 in connection with the original Loan Agreement, and that such Lien has continued perfected and uninterrupted in favor of Lender and the Prior Agent since such date.
