CONFIRMATORY SECURITY AGREEMENT

WHEREAS CIMENT McINNIS INC. / McINNIS CEMENT INC. (the **Grantor**), having its registered office at 205-1350 René-Lévesque Blvd. West, Montréal, Québec, H3G 2W2, Canada **(i)** is the registered owner of the Canadian trademarks and trademark applications listed in Schedule "A" hereto and may, in the future, become the registered owner of additional Canadian trademarks and trademark applications (collectively, the **Canadian Trademarks**), and **(ii)** is the registered owner of the United States trademarks and trademark applications listed in Schedule "B" hereto and may, in the future, become the registered owner of additional United States trademarks and trademark applications (collectively, the **US Trademarks** and together with the Canadian Trademarks, **Intellectual Property**);

WHEREAS BEAUDIER INC. (the **Creditor**), having its head office at Beaudier Inc., 1000 De La Gauchetière Street West Suite 4300, Montréal (Québec) H3B 4W5, and McInnis Cement Inc. (which amalgamated with McInnis Holding Inc. to form the Grantor, and is herein referred to as the **Original Borrower**) entered into a deed of hypothec on June 26, 2019 (the **Security Document**), pursuant to which the Original Borrower granted to the Creditor a hypothec on, and a security interest in and to, among other things, the Intellectual Property;

WHEREAS the Original Borrower and the Creditor have perfected (rendered opposable) the Security Document in the Intellectual Property in accordance with the laws of the Province of Québec, Canada;

WHEREAS on June 30, 2019, the Original Borrower amalgamated with McInnis Holding Inc., with the resulting entity from the amalgamation being the Grantor;

WHEREAS the Grantor and the Creditor are desirous of recording the Security Document and the additional security created hereunder in the Intellectual Property with the United States Patent and Trademark Office and with the Canadian Intellectual Property Office;

NOW THEREFORE, the Grantor and the Creditor hereby confirm that the Grantor and the Creditor had entered into the Security Document, pursuant to which the Grantor granted to the Creditor a hypothec on, and a security interest in and to, among other things, the Intellectual Property.

AND, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, intending to be legally bound, the Grantor does hereby further grant to the Creditor a security interest in the Intellectual Property.

AND each party hereto does hereby further acknowledge and affirm that the rights and remedies of the Creditor with respect to the security interest in the Intellectual Property made and granted hereby are more fully set forth in the Security Document, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

THE PARTIES FURTHER AGREE that the Grantor shall record this Confirmatory Security Agreement with **(i)** the Canadian Intellectual Property Office, with respect to the Canadian Trademarks, and **(ii)** the United States Patent and Trademark Office (together with a filing at the Office of Revenue in Washington, D.C.), with respect to the US Trademarks.

The parties hereto acknowledge that they have required that this Confirmatory Security Agreement and all related documents be prepared in English. *Les parties aux présentes reconnaissent avoir demandé que la présente convention et tous les documents connexes soient rédigés en anglais.*
