TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment") is effective as of the 24 day of July, 2019 by DNC Parks & Resorts at Yosemite, Inc., incorporated in the State of Delaware with a business address c/o Delaware North, 250 Delaware Avenue, Buffalo, NY 14202 ("Assignor") to Yosemite Hospitality LLC, a Delaware limited liability company with a business address of 2400 Market Street Philadelphia, PA 19103 ("Assignee").

WHEREAS, Assignor claims ownership of all right, title and interest in and to certain trade names, trademarks, and service marks used or held for use in connection with its operations at Yosemite National Park pursuant to Concession Contract No. CC-YOSE004-93, and the applications and registrations therefor, as identified on Schedule A attached hereto (the "Assigned Marks");

WHEREAS, Assignor commenced an action against the United States relating to, *inter alia*, the Assigned Marks, *DNC Parks & Resorts at Yosemite, Inc. v. United States*, Case No. 1:15-cv-91934-PEC, filed at the United States Court of Federal Claims (the "Lawsuit");

WHEREAS, Assignor desires to assign to Assignee, pursuant to the Settlement and Release Agreement between Assignor, Assignee, and the United States of America, effective July 15, 2019 (the "Settlement Agreement"), all right, title and interest in and to the Assigned Marks, any and all applications for registration and registrations therefor and the goodwill associated therewith;

WHEREAS, it is desired that the present Assignment may be made of record in the United States Patent and Trademark Office, and any other domestic or foreign authority.

NOW THEREFORE, in consideration of the foregoing premises and the covenants and payments in the Settlement Agreement, and intending to be legally bound hereby, Assignor hereby transfers, conveys and assigns to Assignee all of its right, title, and interest in and to the Assigned Marks, including the goodwill associated therewith and the portion of the business to which such marks pertain, and all other rights in and to the Assigned Marks throughout the United States and worldwide, in perpetuity, and all rights to damages and profits, due or accrued, arising out of past infringements of said Assigned Marks, and the right to sue for and recover the same.

This Assignment is being executed and delivered pursuant to the Settlement Agreement and shall be construed consistently therewith.
