TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“**Assignment**”) is made by and between Cree, Inc., a North Carolina corporation having its principal offices at 4600 Silicon Drive, Durham, North Carolina 27703, USA (“**Assignor**”), and IDEAL INDUSTRIES LIGHTING LLC, a Delaware limited liability company having its principal offices at 1375 Park Avenue, Sycamore, Illinois 60178, USA (“**Assignee**”), as of the date set forth below.

WHEREAS, Assignor is selling to IDEAL Industries, Inc., of which Assignee is a wholly-owned subsidiary, contemporaneously with the execution and delivery of this Assignment at a closing on the date hereof, the Acquired Assets (as defined in the Purchase Agreement) pursuant to the Asset Purchase Agreement dated as of March 14, 2019, between IDEAL Industries, Inc. and Assignor (the “**Purchase Agreement**”) and the Intellectual Property Assignment and License Agreement dated on the date hereof, among IDEAL Industries, Inc. (together with certain designated Affiliates thereunder, including Assignee) and Assignor (the “**IPALA**”), providing for, among other things, the sale to Assignee or an Affiliate of Assignee by Assignor of all of Assignor’s right, title and interest in and to the Assigned Trademarks (as set forth below);

WHEREAS, the term “**Trademarks**” means all trademarks, design marks, logos, service marks, certification marks, official marks, trade names, business names, corporate names, trade dress, distinguishing guises, slogans, meta tags, SKU codes and other product identification codes and numbers, and other characters, brand elements or other distinguishing features or indicia of source or origin, used in connection with goods or services, whether or not registered or the subject of an application for registration and whether or not registerable, and all related goodwill and all rights with respect thereto, whether arising under the laws of the United States or any state or territory thereof or any other jurisdiction anywhere in the world, and registrations and applications for registration with respect to any of the foregoing;

WHEREAS, the term “**Assigned Trademarks**” means all Trademarks listed on Exhibit A hereto, together with any registrations or applications therefor, all common law rights therein and thereto, all rights thereunder and with respect thereto, and all goodwill associated therewith and/or symbolized thereby;

WHEREAS, Assignee is desirous of acquiring all of Assignor’s right, title and interest in and to the Assigned Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby unconditionally and irrevocably sell, assign, transfer, convey and deliver to Assignee, free and clear of all liens, encumbrances, rights and claims of any third party except for such permitted liens and encumbrances as expressly provided in the Purchase Agreement, IPALA, and other agreements entered into pursuant thereto, Assignor’s entire right, title and interest in and to all of the following, throughout the world:

- (a) the Assigned Trademarks;
- (b) all rights to apply for, file, prosecute, register, maintain, extend and renew, in any and all countries of the world all rights with respect to Trademarks and other governmental grants or issuances of any type with respect to the Assigned Trademarks;
- (c) to the extent they exist, any and all remedies, claims, causes of action and other enforcement rights of any kind (whether known or unknown or whether currently pending, filed, or otherwise, and whether accrued or accruing in the past, present or future) under, pursuant to, or on account of, any of the


