RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made effective as of August 6, 2019 by and from JPMORGAN CHASE BANK, N.A., a national banking association, with an address at 10 S. Dearborn St., 22nd Floor, Chicago, IL 60603, in its capacity as US administrative agent (in such capacity, the “Grantee”) for certain Persons party to the Second Amended and Restated Credit Agreement dated April 30, 2008 between Grantee and such Persons, on the one hand, and Grantor, on the other hand (the “Credit Agreement”), to and in favor of PRINOVA FLAVORS LLC (f/k/a PII FLAVORS, LLC), a Delaware limited liability company, with an address at 6525 Muirfield Drive, Suite 100, Hanover Park, IL 60133 (the “Grantor”).

A. In connection with the Credit Agreement and the Security Agreement referenced in such Credit Agreement, Grantor executed and delivered to Grantee a Trademark Security Agreement dated December 16, 2009 granting a security interest in the Trademark Collateral in favor of Grantee (the “Trademark Security Agreement”). The Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 16, 2009 at Reel 4115, Frame 0485.

B. Grantee has agreed to confirm its termination and release of the security interest in the Trademark Collateral granted in the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, it is hereby agreed that:

1. Definitions. All capitalized terms not defined herein shall have the respective meanings given to them in the Credit Agreement, the Security Agreement and/or the Trademark Security Agreement, as applicable.


2. Release of Security Interest. Grantee hereby confirms its full release, discharge and termination of, and hereby fully releases, discharges and terminates, the security interest in the Trademark Collateral granted to Grantee by Grantor pursuant to the Trademark Security Agreement, including without limitation the security interest granted in the Trademarks and Trademark registrations identified on Exhibit A attached hereto, and Grantee hereby authorizes Grantor and any of its agents to record such release with the United States Patent and Trademark Office and undertake all steps as may be necessary to give effect to the termination, discharge and release of the security interest over the Trademark Collateral granted pursuant to the Trademark Security Agreement, in accordance with the terms of this Release.
