Trademark Assignment Agreement

NOW THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor sells, assigns and transfers unto Assignee, and its successors and assigns, all of its rights, title and interest in and to the Trademark, and the registration therefor, together with the goodwill of the businesses connected with the use of and symbolized by the Trademark, and including Assignor's entire rights, title and interest in and to any and all causes of action and rights of recovery for past infringement of the Trademark. Assignor hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement inconsistent with this Assignment. Assignor shall, without further consideration, execute any additional documents and take such further action as may be requested to vest in Assignee good, valid and marketable title to the Trademark.


