RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of August 1, 2019 (the "Release"), is made by ANTARES CAPITAL LP (successor to General Electric Capital Corporation), as administrative agent (in such capacity, together with its successors and permitted assigns, the "Agent"), in favor of CLAIRE-SPRAYWAY, INC., a Delaware corporation ("Claire-Sprayway"), CHEMICAL PACKAGING CORPORATION, a California corporation ("CPC"), CAMIE CAMPBELL, INC., a Missouri corporation ("Camie Campbell"), MAID BRANDS, INC., a Missouri corporation ("Maid Brands"), and HOLY COW LLC, a Delaware limited liability company ("Holy Cow," and together with Claire-Sprayway, CPC, Camie Campbell, and Maid Brands, the "Grantors"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Guaranty and Security Agreement (as defined below).

WITNESSETH

WHEREAS, the Grantors and the Agent entered into that certain Guaranty and Security Agreement, dated as of July 31, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement");

WHEREAS, pursuant to the Guaranty and Security Agreement, (i) Claire-Sprayway executed the Trademark Security Agreement, dated as of July 31, 2015 (the "Claire-Sprayway Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office ("USPTO") on July 31, 2015 at Reel/Frame No. 5589/0324, (ii) CPC executed the Trademark Security Agreement, dated as of July 31, 2015 (the "CPC Trademark Security Agreement") and recorded with the USPTO on July 31, 2015 at Reel/Frame No. 5589/0301, (iii) Camie Campbell executed the Trademark Security Agreement, dated as of July 31, 2015 (the "Camie Campbell Trademark Security Agreement") and recorded with the USPTO on July 31, 2015 at Reel/Frame No. 5589/0293 and the Patent Security Agreement, dated as of July 31, 2015 (the "Patent Security Agreement") and recorded with the USPTO on July 31, 2015 at Reel/Frame No. 36232/0131, (iv) Maid Brands executed the Trademark Security Agreement, dated as of July 31, 2015 (the "Maid Brands Trademark Security Agreement") and recorded with the USPTO on July 31, 2015 at Reel/Frame No. 5589/0367, and (v) Holy Cow executed the Trademark Security Agreement, dated as of July 31, 2015 (the "Holy Cow Trademark Security Agreement" and together with the Claire-Sprayway Trademark Security Agreement, CPC Trademark Security Agreement, Camie Campbell Trademark Security Agreement, and Maid Brands Trademark Security Agreement, the "Trademark Security Agreements") and recorded with the USPTO on July 31, 2015 at Reel/Frame No. 5589/0903, pursuant to which the Grantors mortgaged, pledged and hypothecated to the Agent for the benefit of the Secured Parties, and granted to the Agent for the benefit of the Secured Parties a Lien on and security interest in all of their right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreements) and Patent Collateral (as defined in the Patent Security Agreement).

WHEREAS, pursuant to the Assignment of Intellectual Property Security Agreement, dated as of August 21, 2015 (the "Assignment"), and recorded September 25, 2015 with the USPTO at Reel/Frame Nos. 5630/0900 and 36688/0230, General Electric Capital Corporation assigned and transferred to Antares Capital LP and its successors and assigns, all of its rights, title and interest in and to the Trademark Security Agreements and the Patent Security Agreement.

WHEREAS, the Grantors have requested that the Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral and Patent Collateral.


NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its

security interest in all right, title and interest in, to and under all of the Trademark Collateral and Patent Collateral, including the trademark registrations, trademark applications, issued patents, and patent applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral and Patent Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral and Patent Collateral under the Guaranty and Security Agreement, the Trademark Security Agreements, the Patent Security Agreement and the Assignment.




