**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 1, 2019 (the "Release"), is made by ANTARES CAPITAL LP, as administrative agent (in such capacity, together with its successors and permitted assigns, the "Agent"), in favor of FOLLMER DEVELOPMENT, INC., a California corporation ("Follmer"), PAR-WAY GROUP, INC., a Missouri corporation ("Par-Way"), THE PENRAY COMPANIES, INC., a Delaware corporation ("Penray"), and CHICAGO AEROSOL, LLC, a Delaware limited liability company (f/k/a CA ACQUISITION, LLC, an Illinois limited liability company) ("Chicago Aerosol") and collectively with Follmer, Par-Way, and Penray, the "Grantors"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Guaranty and Security Agreement (as defined below).

**WITNESSETH**

WHEREAS, the Grantors and the Agent entered into that certain Guaranty and Security Agreement, dated as of July 31, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement");

WHEREAS, pursuant to the Guaranty and Security Agreement, (i) Follmer executed the Trademark Security Agreement, dated as of January 15, 2019 (the "Follmer Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office ("USPTO") on January 15, 2016 at Reel/Frame No. 5710/0611, (ii) Par-way executed the Trademark Security Agreement, dated as of February 17, 2017 (the "Par-Way Trademark Security Agreement") and recorded with the USPTO on May 4, 2017 at Reel/Frame No. 6049/0378, (iii) Penray executed the Trademark Security Agreement, dated as of June 1, 2017 (the "Penray Trademark Security Agreement") and recorded with the USPTO on June 1, 2017 at Reel/Frame No. 6074/0430, and (iv) Chicago Aerosol executed the Trademark Security Agreement, dated as of October 31, 2017 (the "Chicago Aerosol Trademark Security Agreement" and together with the Follmer Trademark Security Agreement, Par-Way Trademark Security Agreement and Penray Trademark Security Agreement, the "Trademark Security Agreements") and recorded with the USPTO on November 1, 2017 at Reel/Frame No. 6194/0497, pursuant to which the Grantors mortgaged, pledged and hypothecated to the Agent for the benefit of the Secured Parties, and granted to the Agent for the benefit of the Secured Parties a Lien on and security interest in all of their right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreements).


WHEREAS, the Grantors have requested that the Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral under the Guaranty and Security Agreement and the Trademark Security Agreements.
