**ARTICLES OF ORGANIZATION  
INCLUDING ARTICLES OF CONVERSION**

---

Pursuant to §§ 57D-2-21, 57D-9-20 and 57D-9-22 of the General Statutes of North Carolina, the undersigned does hereby submit these Articles of Organization Including Articles of Conversion for the purpose of forming a limited liability company pursuant to the conversion of another eligible entity.

1. The name of the limited liability company is: National Power, LLC. The limited liability company is being formed pursuant to a conversion of another business entity.
2. The name of the converting business entity is: National Power Corp. The organization and internal affairs of the converting business entity are governed by the laws of the state of North Carolina. A plan of conversion has been approved by the converting business entity as required by law.
3. The converting business entity is a domestic corporation.
4. The mailing address of the converting entity prior to the conversion is 4541 Preslyn Drive, Raleigh, Wake County, North Carolina 27616-3178. The mailing address of the resulting business entity is the same as the mailing address of the converting business entity.

9. The limited liability company does not have a principal office.



To the full extent from time to time permitted by law, no person who is serving or who has served as a manager of the limited liability company shall be personally liable in any action for monetary damages for breach of his or her duties as a manager, whether such action is brought by or in the right of the limited liability company or otherwise, so long as such person performs his or her duties as such in good faith, in a manner he reasonably believes to be in the best interests of the limited liability company, and with such care as an ordinarily prudent person in a like position would use under similar circumstances. Neither the amendment or repeal of this Article, nor the adoption of any provision of these Articles of Organization inconsistent with this Article, shall eliminate or reduce the protection afforded by this Article to a manager of the limited liability company with respect to any matter which occurred, or any cause of action, suit, or claim which but for this Article would have accrued or arisen, prior to such amendment, repeal, or adoption.
11. These articles will be effective at 5:00 p.m. on June 27, 2019.
