
STATEMENT OF CORRECTION OF TITLE OF TRADEMARKS

This STATEMENT OF CORRECTION OF TRADEMARK TITLE (this "Correction") is effective as of December 17, 2018 (the "Effective Date") and made by **Wine.com, Inc.**, a corporation of Delaware, (hereinafter referred to as "Assignor") and **Wine.com, LLC**, a limited liability company organized under the laws of Delaware (hereinafter referred to as "Assignee"). Assignor and Assignee state:

- A. The Trademark Assignment Agreement and Deed of Assignment executed by Assignor and Assignee dated as of the Effective Date purported to assign from Assignor to Assignee the entire right, title, interest, and related goodwill to Assignor's trademarks (the "Marks"), and any trademark registration thereof.
- B. The Deed of Assignment from Assignor to Assignee was recorded with the U.S. Patent and Trademark Office on December 21, 2018 at Reel/Frame: 006578/0913.
- C. On November 14, 2018 (the "Reorganization Date") Wine.com, Inc. changed its name from Wine.com, Inc. to Wine.com OPCO, Inc. Subsequently and on that same date, Wine.com OPCO, Inc. was converted into Wine.com, LLC. Simultaneously a different related entity, Wine.com Holdings, Inc. was renamed Wine.com, Inc.
- D. As a result of this reorganization, on the Effective Date the entity named Wine.com, Inc. was not the owner of the Marks, so could not assign them to Assignee.
- E. For that reason, the Trademark Assignment Agreement and Deed of Assignment were mistakenly executed and are void because they did not transfer any right, title, interest, or related goodwill in the Marks.
- F. Assignor and Assignee wish to correct the record accordingly and, if possible, to remove the Deed of Assignment recorded at Reel/Frame: 006578/0913 from the title for the Marks.


