**GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

**July 31, 2019**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, GIGAMEDIA ACCESS CORPORATION D/B/A GIGATRUST, a Delaware corporation with its principal address at 607 Herndon Parkway, Suite 302, Herndon, Virginia 20170 (the “Grantor”), hereby grants to CRYSTAL FINANCIAL LLC, a Delaware limited liability company with offices at Two International Place, 17<sup>th</sup> Floor, Boston, Massachusetts 02110 (the “Grantee”), a continuing security interest in (i) all of the Grantor’s right, title and interest in, to and under the United States trademarks, trademark registrations and trademark applications (the “Marks”) set forth on **Schedule A** attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.


THIS AGREEMENT is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantor, as such term is defined in the Guaranty and Security Agreement by, among others, the Grantor and the Grantee, dated as of the date hereof (as amended, modified, restated and/or supplemented from time to time, the “Security Agreement”). The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference, including all of Sections 8.12 (Governing Law and Jurisdiction) and 8.13 (Waiver of Jury Trial). In the event that any provisions of this agreement are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
