1. The name of the corporation is GetGo, Inc., a corporation organized and existing under and by virtue of the general Corporation Law of the State of Delaware (the "Company").
2. The address of the Company's registered agent as currently stated on its Certificate of Incorporation is, 1209 Orange Street, Wilmington, DE 19801.
3. The Company, by a resolution of its Board of Directors duly adopted by unanimous written consent executed October 26, 2017, approved the proposed amendment of the Certificate of Incorporation of the Company.
