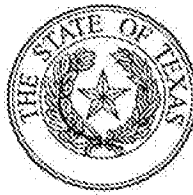

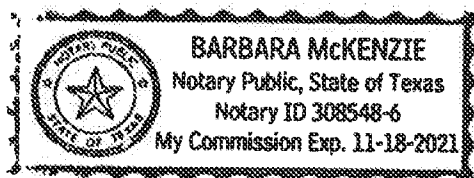

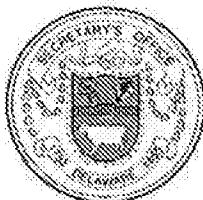

4. This Certificate of Merger, and the merger provided for herein, shall be effective on February 28, 2019 at 11:15 a.m. (the "**Effective Time**").


