RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 9th day of August, 2019, by Freeport Financial Partners LLC, a Delaware limited liability company, as agent for certain lenders (in such capacity, "Freeport"), in favor of Infinite Cohesion LTD, an Ohio limited liability company and EMS LinQ, Inc., a Delaware corporation (collectively, the "Company").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Freeport hereby (a) unconditionally, irrevocably and absolutely terminates, cancels, releases and forever discharges all liens and security interests granted by each Company in favor of Freeport in the Trademark Collateral (as such term is defined in the Trademark Security Agreement) including without limitations the trademarks listed on Schedule A attached hereto pursuant to that certain Trademark Security Agreement, dated as of November 30, 2018, executed by Company in favor of Freeport (the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on November 30, 2018 at Reel/Frame 6542/0562 and (b) assigns to each Company all of Freeport's right, title and interest (if any) in and to the Trademark Collateral.


Freeport has the requisite power and authority to release and discharge its security interest in and to the Trademark Collateral.
