INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This **INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT** (this “**Agreement**”) is made as of July 12, 2019, from NUTRITION EXPRESS CORPORATION, a California corporation (“**Nutrition Express**”), FITNESS LABS NUTRITION CORPORATION, a California corporation (“**Fitness Labs**”), LINDBERG NUTRITION, INC., a California corporation (“**Lindberg Nutrition**”), LINDBERG NUTRITION STORES, INC., a California corporation (“**Lindberg Stores**”, and together with Nutrition Express, Fitness Labs and Lindberg Nutrition, the “**Assignor**”), to 2575 TCA, LLC, a California limited liability company (“**Assignee**”) and a wholly-owned subsidiary of PIPING ROCK HEALTH PRODUCTS, LLC, a New York limited liability company. Capitalized terms used but not defined herein shall have the respective meanings ascribed to them in the Purchase Agreement (defined below).

RECITALS

WHEREAS, this Agreement is being delivered pursuant to that certain Asset Purchase Agreement, dated as of even date herewith, by and among Assignor, Assignee, and the other Persons set forth on the signature pages thereto (the “**Purchase Agreement**”);

WHEREAS, in accordance with the Purchase Agreement, Assignor is transferring and assigning to Assignee its right, title and interest in and to all intellectual property and all proprietary formulae owned or possessed by Assignor, in each case used or held for use in the conduct of the Business (including Assignor's goodwill therein), including but not limited to the items listed on Exhibit A attached hereto (“**Intellectual Property**”), effective as of the Closing; and

WHEREAS, Assignee desires to obtain all right, title and interest in and to the Intellectual Property according to the terms of the Purchase Agreement and this Agreement.

NOW, THEREFORE, in consideration of the premises and agreements contained herein and in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby act and agree as follows:

1. Assignment of the Intellectual Property. Assignor hereby sells, assigns, transfers and conveys to Assignee, its right, title and interest in and to the Intellectual Property, including all associated goodwill.

2. Assistance. From time to time, as and when requested by Assignee, at Assignee's expense, Assignor shall execute and deliver, or cause to be executed and delivered, all documents and instruments and shall take, or cause to be taken, all further or other actions as Assignee may reasonably deem necessary or desirable to consummate the transactions contemplated by this Agreement, including, in the case of Assignor, executing and delivering to Assignee such assignments, deeds, bills of sale, consents, powers of attorney, declarations, affidavits and other instruments as Assignee or its counsel may reasonably request as necessary or desirable for such purpose.

3. Additional Rights and Obligations of the Parties. This Agreement is made subject to and with the benefit of the respective provisions of the Purchase Agreement (including, without limitation, the Disclosure Schedule and the exhibits thereto). Nothing contained in this Agreement shall be deemed to expand, impair, supersede, modify, limit, extend, add to, diminish, amend or in any way affect any of the rights, obligations, agreements, covenants, representations, warranties or indemnities of any party under the Purchase Agreement, which shall remain in full force and effect to the full extent provided therein. In

the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.


4. Miscellaneous. Article IX of the Purchase Agreement is incorporated herein, *mutatis mutandis*, as if fully set forth as a part hereof.


