**RELEASE OF TRADEMARK SECURITY INTEREST**

**THIS RELEASE OF TRADEMARK SECURITY INTEREST** (this “Release”) is made as of August 9, 2019 (“Effective Date”), by JEFFERIES FINANCE LLC, as collateral agent (the “Collateral Agent”), in favor of SESAC, INC., SESAC LLC, THE HARRY FOX AGENCY LLC, RUMBLEFISH, INC. and CHRISTIAN COPYRIGHT LICENSING INTERNATIONAL, INC., (individually, a “Grantor”, and, collectively, the “Grantors”). Capitalized terms used but not herein defined, have the meanings set forth in the Trademark Security Agreement and Security Agreement referenced below, as applicable.

**WHEREAS**, the Grantors are parties to that certain Second Lien Security Agreement, dated as of February 23, 2017 (as amended, modified, refinanced and/or restated from time to time, the “Security Agreement”) in favor of the Collateral Agent pursuant to which the Grantors are required to execute and deliver the Trademark Security Agreement, dated as of February 23, 2017, by Grantors, in favor of Collateral Agent (“Trademark Security Agreement”);

**WHEREAS**, pursuant to the Security Agreement, the Grantors executed and delivered the Trademark Security Agreement to the Collateral Agent for purposes of filing with the United States Trademark and Trademark Office (“USPTO”);

**WHEREAS**, pursuant to the Trademark Security Agreement, the Grantors pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and a security interest in and to all of each Grantor’s right, title and interest, including goodwill, in, to and under all the Collateral (excluding the Excluded Assets) of such Grantor, including all Trademarks of such Grantor (collectively, the “Trademarks”), which includes those United States Trademark registrations and applications listed on the attached Schedule A hereto;

**WHEREAS**, the Trademark Security Agreement was recorded in the USPTO on February 24, 2017 at Reel/Frame 5995/0220; and

**WHEREAS**, the Collateral Agent wishes to release its security interest in the Trademarks.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, for itself and on behalf of the Secured Parties (as defined in the Credit Agreement), hereby irrevocably terminates, releases and discharges any security interest in and lien upon the Trademarks, and assigns, transfers, and conveys to the Grantors any and all right, title or interest in, or to, the Trademarks that the Collateral Agent may hold.

Collateral Agent agrees, at the Grantors’ expense, to take all further actions, and provide to the Grantors and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantors and their successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

Collateral Agent authorizes and requests that the Commissioner of the USPTO and any other applicable governmental authority record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by and constructed and interpreted in accordance with the laws of the State of New York.
