RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST dated as of August 5, 2019, is made by Deerpath Fund Services, LLC, as administrative agent and collateral agent ("Agent").

WHEREAS, Agent and Mesmerize Media LLC (formerly Brite Media LLC), a Delaware limited liability company ("Mesmerize") are parties to that certain Patent and Trademark Security Agreement, dated as of July 25, 2017 (the "2017 Security Agreement") and recorded in the United States Patent and Trademark Office ("PTO") on July 25, 2017 at Reel/Frame 006113/0927 against the trademarks referred to therein and on July 25, 2017 at Reel/Frame 043092/0051 against the patents referred to therein. Mesmerize, together with all other grantors under the 2017 Security Agreement, are collectively referred to herein as "Grantor".

WHEREAS, the 2017 Security Agreement granted, assigned and conveyed to Agent a security interest in each applicable Grantor's entire right, title and interest in and to certain IP Collateral (as defined in the 2017 Security Agreement, including, without limitation all of the patents and trademarks listed on Schedule 1 thereto (the "Patents and Trademarks").

WHEREAS, Grantor has requested that Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest Agent may have in the IP Collateral, including, without limitation, all of the Patents and Trademarks pursuant to the 2017 Security agreement.



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the IP Collateral, including, without limitation, all of Patents and Trademarks listed on Schedule 1 hereto and (ii) any and all other rights it may have under the 2017 Security Agreement.
