Mindspark Interactive Network, Inc., a corporation incorporated on March 18, 1999 pursuant to the provisions of the General Corporation Law of the State of Delaware (the “Corporation”);

DOES HEREBY CERTIFY that the Corporation owns 100% of the capital stock of Ask Applications, Inc. a corporation incorporated on June 13, 2013, pursuant to the provisions of the General Corporation Law of the State of Delaware (the “Subsidiary”) and that this Corporation, by a resolution of its Board of Directors duly adopted resolutions by Unanimous Written Consent pursuant to Section 141 of the General Corporation Law of the State of Delaware dated April 30, 2019 determined to merge the Subsidiary into itself as of the date of the filing of this Certificate pursuant to resolutions substantially similar to the following:

WHEREAS, Mindspark Interactive Network, Inc. (the “Corporation”) owns 100% of the outstanding stock of Ask Applications, Inc. (the “Subsidiary”)

WHEREAS, the undersigned deem it to be advisable and in the best interests of the Corporation to merge the Subsidiary with and into the Company (the “Merger”) pursuant to Section 253 of the General Corporation Law of the State of Delaware; and

WHEREAS, the undersigned deem it to be advisable for the Corporation to change the name of the Corporation to Ask Applications, Inc. upon the filing of a Certificate of Ownership and Merger with the Secretary of State of Delaware.

NOW THEREFORE BE IT RESOLVED, that the Subsidiary be merged with and into the Corporation with the Corporation being the surviving entity of the Merger;

RESOLVED, that the effective time of the Merger (the "Effective Time") shall be upon the filing of a Certificate of Ownership and Merger by the Corporation with the Delaware Secretary of State;

RESOLVED, that at the Effective Time, the Corporation shall assume all of the Subsidiary's liabilities and obligations, the existence, rights, powers, properties and assets of the Corporation shall cease and all rights, privileges, powers, properties and assets of the Subsidiary shall be vested in the Corporation.

RESOLVED, that at the Effective Time of the Merger, the name of the Corporation shall be changed to Ask Applications, Inc.

RESOLVED, that the officers of the Corporation be, and each of them hereby is, authorized, directed and empowered in the name and on behalf of the Corporation (i) to prepare or cause to be prepared, execute, seal and deliver or cause to be delivered, any and all documents and instruments to effectuate any of the foregoing resolutions or any of the transactions contemplated thereby; and (ii) and to take such actions or cause others to take such actions as such officer or officers may deem necessary or advisable in order to carry out and perform the purposes of these resolutions; and

RESOLVED, that all of the actions of the officers of the Corporation that are within the authority conferred by the foregoing resolutions are hereby ratified, confirmed and approved in all respects;
