RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 14, 2019 (the "Release"), is made by ANTARES CAPITAL LP, as administrative agent (in such capacity, together with its successors and permitted assigns, the "Agent"), in favor of SCIQUEST, INC., a Delaware corporation (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Guaranty and Security Agreement (as defined below).

WITNESSETH

WHEREAS, the Grantor and the Agent entered into that certain Guaranty and Security Agreement, dated as of December 28, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement");

WHEREAS, pursuant to the Guaranty and Security Agreement, the Grantor executed the Trademark Security Agreement, dated as of December 28, 2017 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on December 29, 2017 at Reel/Frame No. 6239/0437, pursuant to which the Grantor pledged and granted to the Agent for the benefit of the Secured Parties a Lien on and security interest in all of their right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).


WHEREAS, the Grantor has requested that the Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral under the Guaranty and Security Agreement and the Trademark Security Agreement.
